FEVERISH VOLATILITY PAVES THE WAY FOR A DOVISH TURN



- The NASDAQ 100 fell 7.5% last week, its worst week since the start of the pandemic
- After testing 1.9%, 10-year US Treasury yields fell to 1.76% on Friday
- The Fed is still expected to indicate imminent hikes, though it may signal caution
- Brent crude prices neared US\$90/barrel amid heightened geopolitical risk

Risk asset volatility reached more feverish levels last week after tech stocks had their worst week since March, 2020. The underlying reason for the drop, however, is still positive, as investors seemed to reflect stronger growth ahead due to an impending end to many COVID-related restrictions, something countries like the UK and Sweden have started to roll out.

Bond volatility also rose. This seemed to reflect the inflation outlook. As Brent crude prices neared US\$90/barrel last week, investors priced future upward pressure on prices in the US, which could endure for longer and force the Fed to be more aggressive. Still, so much volatility could translate into a slightly more dovish Fed this week, and some ensuing stability.


THE TREASURY CURVE HAS FLATTENED, A SIGN THE BOND SELL-OFF COULD SLOW



- The yield on 10-year US Treasuries fell almost 11 basis points on Thursday and Friday and 3bp more on Monday.
- The yield difference between 10-year and two-year US Treasuries dropped to 70 basis points, its lowest since November, 2020.
- The Fed pays close attention to the steepness of the yield curve given its impact on the willingness to lend of US banks.
- The flattening could prompt the Fed this Wednesday to suggest it may delay quantitative tightening.

THE VIX INDEX REACHED ITS THIRD HIGHEST LEVEL IN A YEAR AS STOCKS CORRECT


- Actual volatility of markets had spiked since the start of the year, but implied volatility, as measured by the VIX, remained subdued.
- The recent spike in the VIX makes the pricing of some structured products more attractive and also allows some hedges to be unwound.
- Speculative positions in VIX futures are bearish, and the recent spike could continue as these are covered.
- Volatility tends to rise with rates, but the recent spike was driven by a sell-off in some technology stocks.






INVESTORS ARE SHUNNING STAY-AT-HOME STOCKS AS THE OMICRON WAVE PEAKS

- US health officials suggested last week that the wave of new cases caused by the Omicron variant had probably peaked.
- Meanwhile, some countries, including the UK and Sweden, have started to reverse pandemic restrictions.
- This is good news for the global economy but could hamper the near-term growth of some technology companies which thrive when people work from home.
- The long-term growth of these companies, however, may continue.




OIL PRICES HAVE HIT THE HIGHEST SINCE 2014 AS DEMAND RECOVERS FURTHER



- Brent crude closed at US\$88.44/barrel last Wednesday, as geopolitical uncertainty prompted questions about supply stability.
- Demand is probably also recovering, as the Omicron wave seems to have peaked and GDP numbers in the US this week are likely to show its impact on growth was marginal.
- The spike in prices could prompt President Joe Biden to release more strategic petroleum reserves as he tries to contain gasoline prices in an election year.

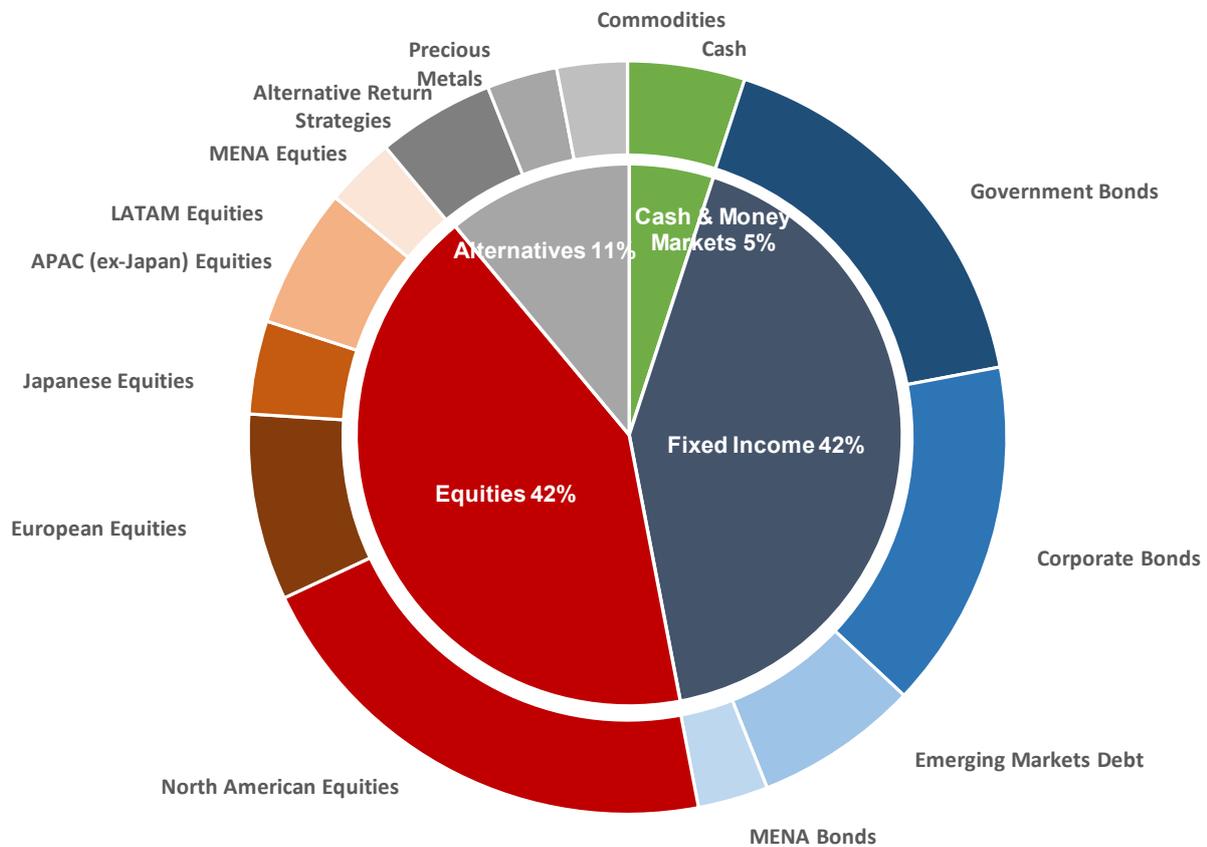
MENA STOCKS CONTINUE TO GAIN AMID MORE LIQUIDITY AND HIGHER OIL PRICES

- The S&P Pan-Arab stock index hit a record last week buoyed by the Saudi and Abu Dhabi markets.
- A slew of expected IPOs, higher foreign ownership limits and rising oil prices are all supporting more liquidity in these markets.
- Growth in the region may also accelerate with higher energy prices.
- The large share of financial stocks in the local indices also has helped the broader region's performance as GCC banks would benefit from higher US dollar interest rates.
