

## FAB Travel Infinite & Travel Signature Credit Cards Campaign

### Terms & Conditions

(Application via FAB Mobile App & FAB Staff assisted journeys only i.e. Customer Initiated journey & digital tablet journeys only)

- Campaign timeline: March 27<sup>th</sup>, 2023 – August 1<sup>st</sup>, 2023
- Credit Cards applied only via FAB Mobile App & FAB Staff assisted journeys only i.e. Customer Initiated journey & digital tablet journeys only will be eligible for this offer.
- It is mandatory to achieve cumulative retail purchase target for each product during the first 60 days from the card issuance/ card booking date.
- This offer is applicable for both banking and non-banking customers including Expats and UAE Nationals
- FAB Travel Elite Infinite card is not eligible for this offer
- Retail purchase targets are as below:
  - FAB Travel Infinite card, with AED 10,000 cumulative retail purchase in first 60 days from card issuance/ booking date, customer will get 100% reversal of Annual i.e. AED 1,500 Annual fee reversal to card subject to fulfilling all terms & conditions. - There is no change in the product's regular benefits.
- Annual Fee will apply (if applicable).
- Customer will receive regular Travel Card Miles as per the product terms & conditions for any spend made on the card as per the respective product's rewards proposition.
- No Card will be considered for this Campaign if the customer has not met all the terms & conditions of this campaign.
- The Campaign will not be applicable for Customers applying via physical application journeys
- Credit Cards booked against Fixed Deposits will not be eligible for this campaign.
- Fulfilment for the campaign will be done in the next month after the completion of 60 days of spend criteria i.e. eligible annual fee reversal will be credited during the last 10 days of the next month. For Example:

- Any Card booked/issued prior to the campaign launch or prior to Campaign Start date will not be eligible for this offer.
